The Creditor-ID of Ledl.net GmbH is AT09ZZZ0000039641. Per failed deduction expenses of EUR 15,- are charged.

The customer uses the ordering type of the provider by means of fax form and confirms with its signature to be at least 18 years old. The customer confirms to have read the current price list and the GTC of the provider under: [www.domainttechnik.com/agb](http://www.domainttechnik.com/agb) and accepts them expressly as obligatorily. Each cancellation of the present treaty can take place within the prescribed period in each case according to the GTC and requires written form in each case. The reseller-contract enables the reseller a discount of up to 50% for all offered services on condition that the payment is made within the prescribed period with direct debit or credit card as well as a minimum number of three customers in each annual period. The accounting of all services to the final customers as well as any support and assistance for the final customer have to take place exclusively via the reseller. On delay of payment overdue fines and late interest at a value of 8% are charged because of additional expenses. Agreed upon area of jurisdiction is the BG Neumarkt/Sbg.
